

Petition Instructions:

Part 1 The shaded area indicating the **county** in which the petition was circulated above the registered voters signature must be completed.

Part 2 One to five registered voters may complete a box by **printing their name and address and signing** in the space provided.

All signers on a petition must be a **registered voter** in the county designated on the petition.

Part 3 In the box "DECLARATION OF PERSON CIRCULATING SECTION OF RECALL PETITION" you must fill in all shaded areas in your own handwriting. Follow the instructions carefully to avoid rejection of the petition.

- Only **registered voters of California** may sign and circulate petitions.

- You may circulate as many petitions as you wish, however you can only sign the petition for recall once.

- You can circulate petitions in more than one county, but all signers of each petition **must be from the same county**. Start a new petition for each county.

- A petition is valid even with **one** signature.

Example Petition

Part 1

The **COUNTY** in which the petition was circulated, **MUST BE FILLED IN**. All signers must be registered voters in county listed.

IMPORTANT: DECLARATION OF PERSON CIRCULATING SECTION OF RECALL PETITION:
(MUST BE IN CIRCULATOR'S OWN HANDWRITING)

(4) That I showed each signer a valid and unfalsified "Official Top Funders" sheet, as required by Elections Code Section 107.
