SACRAMENTO, Calif. (AP) — More than 700,000 immigrants living illegally in California will gain access to free health care starting Monday under one of the state's most ambitious coverage expansions in a decade.

It's an effort that will eventually cost the state about **\$3.1 billion per year** and inches California closer to **Democrats' goal of providing universal health care to its roughly 39 million residents.**

PETITION FOR STATE OFFICER RECALL

TO THE HONORABLE SECRETARY OF STATE OF CALIFORNIA, Pursuant to the California Constitution and California Election laws, we the undersigned registered and qualified electors of the County of _____, California, respectfully state that we seek the recall and removal of Gavin Newsom, holding the state office of Governor of California. We demand an election of a successor to that office. The following Notice of Intention to Circulate Recall Petition was served on February 26, 2024 to Governor Newsom. TO THE HONORABLE GAVIN NEWSOM: Pursuant to section 11020, California Elections Code, the undersigned registered qualified voters of the State of California hereby give notice that we are the proponents of a recall petition, and we intend to seek your recall and removal from the office of Governor of the State of California. The grounds for this recall are as follows: Governor Newsom has abandoned the state to advance his Presidential ambitions, leaving behind a \$68 Billion budget deficit and a public safety, immigration, and education crisis. He granted 700,000 illegal immigrants free health care at a cost to taxpayers of \$3 billion annually, while cutting vital programs for veterans, school children, the disabled and the homeless. He kept schools closed during Covid longer than other states allowing California students to fall further behind in basic skills such as language and mathematics. He closed prisons and ordered the release of thousands of dangerous criminals onto our streets. He weakened our public safety laws, creating an epidemic of smash and grab crimes and violent assaults. Californians suffer under the highest taxes in the nation and the highest home prices outside Hawaii, yet Newsom is undermining Prop. 13, forcing Californians to pay even more. In order to Rescue California from Newsom's disastrous policies, we the people have come together to take this action and to restore and protect our quality of life.
